GEORGE WARREN FULLER AWARD Patricia Stabler

Retired and PA-AWWA Volunteer: **Chester Water Authority**

Pat has a BA in Biology from Swarthmore College and an MSc. in Water Resources Engineering from Villanova University. She worked for five years in water research for the Stroud Water Research Center and the Academy of Natural Science of Philadelphia. She then worked for several years at Roberts Filter as a project manager on 20 to 30 projects annually, and became an expert in rapid sand filter design, construction and rehabilitation. Along the way, she became a registered professional engineer.

Pat went on to the Chester Water Authority for almost 25 years where she had various positions of progressive more responsibility culminating in Chief of Treatment for a 60 mgd surface water treatment facility. She is past chair of the Pennsylvania AWWA Water Utility Council and was awarded the 2006 Pennsylvania AWWA Operators Meritorious Service Award.

Pat has a passion for excellence in service to the water industry in general and drinking water quality in particular. In 2013, under her direction, the facility received the Partnership for Safe Drinking Water Phase IV Excellence Award, currently only one of two in Pennsylvania.
