Revenue Department Releases December 2020 Collections

Pennsylvania collected \$3.7 billion in General Fund revenue in December, which was \$465.8 million, or 14.5 percent, more than anticipated, Revenue Secretary Dan Hassell reported. Fiscal year-to-date General Fund collections total \$18.5 billion, which is **\$467.1 million, or 2.6 percent, above estimate.**

Sales tax receipts totaled \$1.0 billion for December, \$54.4 million above estimate. Year-to-date sales tax collections total \$6.4 billion, which is **\$54.4 million, or 0.9 percent, more than anticipated.**

Personal income tax (PIT) revenue in December was \$1.2 billion, \$36.0 million above estimate. This brings year-to-date PIT collections to \$7.4 billion, which is **\$36.0 million, or 0.5 percent, above estimate.**

December corporation tax revenue of \$771.3 million was \$308.8 million above estimate. Year-to-date corporation tax collections total \$2.2 billion, which is **\$310.4 million, or 16.6 percent, above estimate.**

Inheritance tax revenue for the month was \$104.8 million, \$14.4 million above estimate, bringing the year-to-date total to \$605.0 million,

which is **\$14.3 million, or 2.4 percent, above estimate.**

Realty transfer tax revenue was \$68.6 million for December, \$19.2 million above estimate, bringing the fiscal-year total to \$316.9 million, which is **\$19.2 million, or 6.5 percent, more than anticipated.**

Other General Fund tax revenue, including cigarette, malt beverage, liquor and gaming taxes, totaled \$178.5 million for the month, \$17.6 million above estimate and bringing the year-to-date total to \$994.4 million, which is **\$17.5 million, or 1.8 percent, above estimate.**

Non-tax revenue totaled \$375.6 million for the month, \$15.4 million above estimate, bringing the year-to-date total to \$665.3 million, which is **\$15.3 million, or 2.4 percent, above estimate.**

In addition to the General Fund collections, the **Motor License Fund** received \$172.9 million for the month, \$11.2 million below estimate. Fiscal year-to-date collections for the fund - which include the commonly known gas and diesel taxes, as well as other license, fine and fee revenues - total \$1.4 billion, which is **\$5.8 million, or 0.4 percent, below estimate.**

As part of the state budget recently signed by Gov. Tom Wolf, an amendment to the Fiscal Code required the Department of Revenue to revise revenue estimates for the 2020-21 Fiscal Year.

Those revised estimates are reflected in the information above.

Jim Miller Named Regional Director of Southwest Regional Office Leadership change follows retirement of Ronald Schwartz

Effective January 2, 2021, James "Jim" Miller became the regional director of the Pennsylvania Department of Environmental Protection's (DEP) Southwest Regional Office. He replaces Ronald Schwartz, PE, BCEE, who recently retired after nearly 35 years of service. Miller, who previously led DEP's Northwest Regional Office for four and a half years, will manage field operations for Allegheny, Beaver, Cambria, Fayette, Greene, Washington, Westmoreland, and Somerset counties.

"Jim brings a commonsense approach to management, and his experience in a variety of roles within DEP makes him the right leader at the right time. I am confident that Jim's emphasis on relationship building will continue the Southwest's progress in recent years," said DEP Secretary Patrick McDonnell.

Miller has served DEP for over 30 years. Prior to being named regional director for DEP's Northwest Regional Office, he was assistant regional director for the Northcentral Regional Office for six years after working his way up from inspector to program manager. Miller began his DEP career as an inspector in the Southeast Regional Office's waste management program. Miller holds a Bachelor of Science degree in environmental biology from the University of Pittsburgh at Johnstown.

"I look forward to meeting with the various stakeholders in the southwest region and am excited for this opportunity to continue the work I've done in other regions promoting responsible development and environmental stewardship, two goals that are not mutually exclusive," said Miller.

McDonnell points to Miller and Schwartz's shared emphasis on communication and efficiency as constants for the region, "Jim and Ron are both natural problem solvers, a trait that has become a hallmark of each director's career in public service and has furthered DEP's mission."

"Ron's leadership was instrumental in DEP achieving a 90 percent reduction in the permitting backlog in the Southwest region during his tenure as regional director," added McDonnell. "On behalf of DEP, I wish him all the best in his well-deserved retirement."

John Holden, clean water program manager in DEP's Northwest Regional Office, will serve as acting regional director for that office.

DEP Lifts Drought Watch or Warning for 20 Counties, Three Counties Remain on Watch

After a meeting of the Commonwealth Drought Task Force, the Pennsylvania Department of Environmental Protection (DEP) today lifted drought watch or warning for 20 counties, returning them to normal status. Three counties remain on drought watch.

Drought watch or warning has been lifted for Bradford, Cameron, Columbia, Cumberland, Elk, Forest, Jefferson, Juniata, Lycoming, McKean, Montour, Northumberland, Perry, Potter, Snyder, Sullivan, Tioga, Union, Warren, and Wyoming counties.

Centre and Clearfield counties remain on drought watch. Clinton County is also on drought watch, having improved from drought warning conditions.

"We're getting close. Recent rainfall brought good news for many counties," said DEP Secretary Patrick McDonnell. "But three counties have a little ways to go to return to normal conditions. We ask all water consumers on drought watch to remain mindful and continue to reduce their water use a modest amount."

Consumers on drought watch are asked to reduce their individual water use 5-10 percent, or three to six gallons of water per day.

DEP has notified water suppliers in Centre, Clearfield, and Clinton counties of the need to monitor their supplies and update their drought contingency plans as necessary. Varying localized conditions may lead water suppliers or municipalities to ask residents for more stringent conservation actions.

Several public water suppliers in these counties are requiring consumers to reduce their water use or requesting voluntary reductions. Suppliers in a few other counties are still asking for voluntary reductions as water levels recover. There are many ways to reduce water use indoors, including:

- Don't let the faucet run while brushing your teeth or shaving. Shorten the time you let the water run to warm up before showering. Use a bucket to catch the water and reuse it to water your plants.
- Run the dishwasher and washing machine only with full loads.
- Repair household leaks. For example, a leaking toilet can waste up to 200 gallons of water daily.
- Sweep your sidewalk, deck, or driveway, rather than hosing it off.
- Replace older appliances with high-efficiency, front-loading models that use about 30 percent less water and 40-50 percent less energy.

- Install low-flow plumbing fixtures and aerators on faucets.

DEP makes drought watch, warning, or emergency declaration recommendations based on four numeric indicators. The agency gets stream flow and groundwater level data from a statewide network of gauges maintained by the U.S. Geological Survey. In addition, DEP monitors precipitation and soil moisture. DEP also factors in information it receives from public water suppliers.

There are normal ranges for all four indicators, and DEP makes its drought status recommendations after assessing the departures from these normal ranges for all indicators for periods of 3-12 months. Declarations are not based on one indicator alone. DEP shares these data and its recommendations with other state and federal agency personnel who make up the Commonwealth Drought Task Force. Drought watch and warning declarations are determined by DEP, with the concurrence of the task force. Drought emergency declarations follow the same process, with final approval by the Governor.

A drought emergency has not been declared for any county.

The next Drought Task Force meeting will be held on Thursday, January 21, 2021.

EPA Proposes Removing Superfund Designation from Part of North Penn Area 6 Site

The U.S. Environmental Protection Agency (EPA) has proposed the deletion of 1.66 acres of soil and groundwater at the North Penn Area 6 Superfund Site in Lansdale, Montgomery County, Pennsylvania, from EPA's National Priorities List (NPL).

The North Penn Area 6 Site comprises multiple properties contaminated primarily with volatile organic compounds (VOCs) in the soil and groundwater. One of the properties located at 135 East Hancock Street in Lansdale Borough was formerly occupied by the Tate Andale Company and later by the Rogers Mechanical Company. EPA

removed the contaminated soil and installed groundwater treatment at the property.

"Deletion from the NPL is an important milestone because it signals that a portion of the cleanup is complete and that part of the site no longer poses a risk to human health and the environment," said EPA Mid-Atlantic Regional Administrator Cosmo Servidio. "The attention and focus that EPA has placed on the Superfund program is making a real difference in the lives of people living in communities near Superfund sites across the country."

Approximately 6.5 acres of soil and groundwater at the 10-acre property were previously deleted from the NPL in a separate partial deletion action completed by EPA on March 3, 2017, and this area has since been redeveloped into residential townhomes.

The public is invited to comment on this proposed partial deletion. Comments on this proposed deletion must be submitted to EPA on or before January 29, 2021.
